- ✚ STATIONS AIRING 2 HALF HOURS AS ONE HOUR BLOCK ONLY SATURDAY/SUNDAY AIR MONDAY & TUESDAY PRIMARY EPISODES OF CURRENT WEEK. I.E. SATURDAY 9/9/23 – AIR MONDAY 9/04/23 EPISODE & AIR TUESDAY 9/05/22 EPISODE.
- ✚ STATIONS AIRING 4 HALF HOURS AS A TWO HOUR BLOCK ON SATURDAY/SUNDAY - AIR MONDAY & TUESDAY'S EPISODE FIRST THEN AIR WEDNESDAY & THURSDAY SECOND OF THE CURRENT WEEK. I.E. SATURDAY/SUNDAY 9/9 / 9/10 – AIR MONDAY 9/04/23 EPISODE/TUESDAY 9/05/23 EPISODE THEN AIR WEDNESDAY 9/06/23 EPISODE/THURSDAY 9/07/23 EPISODE.
- ✚ STATIONS AIRING OTHER COMBINATIONS, PLEASE AIR ALL PRIMARY EPISODES IN ORDER. IF MORE THAN 5 EPISODES ARE NECESSARY, PLEASE AIR SECONDARY EPISODES IN ORDER FOLLOWING PRIMARY EPISODES.
- ✚ PLEASE NOTE THE SEPARATE WEEKEND AIR SCHEDULE POSTED. THERE WILL NOT BE AN ADDITIONAL FEED FOR THESE PROGRAMS. PLEASE TAKE FEEDS AT THEIR REGULARLY SCHEDULED DELIVERY TIMES AS NOTED ON THE MAIN RUN FEED INFORMATION.
- ✚ EPISODES ARE AVAILABLE FOR A LIMITED TIME. PLEASE DUB OUT EPISODES AIRING ON THE WEEKEND ASAP!!
- ✚ BARTER SPLIT IS 4 NATIONAL / 4 LOCAL
