SHOW DESCRIPTION

BLOODLINE DETECTIVES is an hour long docudrama that highlights how new technologies in Familial DNA testing is helping to solve long outstanding cold cases all over the country. Familial DNA searches are used more and more by law enforcement to break down genetic information which then helps them determine, not only the general characteristics of a potential suspect, but whether a relative might exist that would help them track down that suspect. Familial DNA testing is ground breaking technology that has come to fruition thanks to the huge success in everyone's desire to determine their Genealogy and has opened up a whole new world in how both old and new cases are investigated. EPISODE SYNOPSIS

Ep. 401 –NORCAL RAPIST – “THE NORCAL RAPIST”

For fifteen years, Northern California is haunted by a serial rapist until genetic genealogy finally reveals the shocking identity of the elusive sexual predator.

Ep. 402 – CAROL SUE KLABER - “HORROR BY THE ROADSIDE”

A 16-year-old girl is found murdered near a roadside ditch in the small town of Walton, Kentucky, in 1976. Decades later, can the mystery of who killed Carol Sue Klaber finally be solved?

Ep. 403 – DONNA SUE – “MURDER ON ELM STREET”

In 1987, the brutalized body of a New Mexico woman is discovered inside her apartment. Can genetic genealogy catch the killer almost four decades later?

Ep. 404 – ISABEL SANCHEZ BERNAL – “THE MAMMOTH LAKES MURDER”

When the skeletal remains of a young woman are discovered in 2003, police are left with two questions: who was this Jane Doe, and who was responsible for her murder?

Ep. 405 –NANCY BENNALLACK – “THE COURT REPORTER MURDER”

When the body of a young woman is discovered in 1970, her family never loses hope that one day her killer will be identified. After 52 years, genetic genealogy provides the groundbreaking truth.

Ep. 406 – STACEY LYN CHAHORSKI – “MURDER BY 1-59”

For over 30 years, Dade County police in Georgia work to uncover the identity of a Jane Doe and locate the perpetrator responsible for her murder. Can investigative genetic genealogy be the tool needed to finally crack this cold case?

Ep. 407 – ANITA PITEAU – “THE HUNTINGTON BEACH BODY”

In 1968, the remains of an unidentified woman are discovered. Detectives work for nearly half a century to identify the Jane Doe and the murderer who evaded law enforcement for 50 years.

Ep. 408 – MARISE CHIVERELLA – “THE MURDER OF LITTLE MARISE”

In 1964, when the body of a nine-year-old girl is discovered in Hazleton, Pennsylvania, the community lives in fear that a child predator is hiding in plain sight. Over 50 years later, the truth is finally revealed.

**Ep. 409 – CAROL ANDERSEN & BRYNN RAINEY” –
“THE SOUTH LAKE TAHOE STRANGLER”**

Two unsolved murders from the late 1970’s near Tahoe, California, stump investigators for decades. Can investigative genetic genealogy identify the perpetrator even four decades later?

Ep. 410 – ROBIN BROOKS – “STABBING IN SACRAMENTO”

In 1980, when a young woman is murdered inside her Sacramento apartment, her family never loses hope that her killer will be caught. Exactly forty years later, forensic genetic genealogy may just provide the answers needed.

Ep. 411 – ANGELA BROSSO & MELANIE BERNAS – “THE PHOENIX CANAL KILLER”

In 1992, the remains of a young woman are discovered near a canal in Phoenix, Arizona. Investigators work tirelessly to identify the killer. When another victim’s body is discovered just ten months later, law enforcement begin to worry that there may be a serial killer on the loose.

Ep. 412 – DIANE DAHN – “MOMMY HAS BEEN MURDERED”

In 1998, Santee, California, the police arrive at the home of a young mother who has been brutally killed, they are stunned and relieved to find that her toddler son was unharmed during the brutal killing. When the case goes cold, decades pass, and the victim’s son questions whether he’ll ever see justice for his mother.

Ep. 413 – CATHY SWARTZ – “THE KILLER REALTOR”

In 1988, Three Rivers, Michigan, the body of a young mother is discovered inside her apartment, police are shocked to find her infant daughter unharmed in the next room. Police work tirelessly to identify the killer, but eventually, the case goes cold. The victim’s daughter grows up, never losing hope that one day her mother’s killer will be found.

Ep. 414 – SHANNON LLOYD & RENEE CUEVAS – “DOUBLE HOMICIDE IN THE OC”
When two young women are murdered in close proximity in 1986, Orange County, California, police work tirelessly to apprehend the killer responsible for the brutal murders. Despite extensive police work, the investigation hits a dead end. For decades, the investigation remains cold until a groundbreaking new science provides long awaited answers.

Ep. 415 – DANIEL SKAGGS – “THE MISSISSIPPI RAPIST”
In 1990, Rankin County, Mississippi, a waking nightmare unfolds for a young mother when she is kidnapped and sexually assaulted by a masked assailant. When the case goes cold, the victim lives in fear that her attacker could strike again until thirty years later, when investigative genetic genealogy finally unmask the perpetrator.

Ep. 403 – DONNA SUE – “MURDER ON ELM STREET”

In 1987, the brutalized body of a New Mexico woman is discovered inside her apartment.

Ep. 404 – ISABEL SANCHEZ BERNAL – “THE MAMMOTH LAKES MURDER”

In 2003, the skeletal remains of a young woman are discovered by a hiker.

Ep. 405 – NANCY BENNALLACK – “THE COURT REPORTER MURDER”

In 1970, a young woman is found murdered inside her apartment.

Ep. 406 – STACEY LYN CHAHORSKI – “MURDER BY 1-59”

In 1988, the remains of an unidentified woman are discovered by a sanitation worker near the highway.

Ep. 407 – ANITA PITEAU – “THE HUNTINGTON BEACH BODY”

In 1968, the remains unidentified woman are discovered and the police work over 50 years to solve the case.

Ep. 408 – MARISE CHIVERELLA – “THE MURDER OF LITTLE MARISE”

In 1964, the body of a nine-year-old girl is discovered in a coalmining pit.

Ep. 409 – CAROL ANDERSEN & BRYNN RAINEY – “THE SOUTH LAKE TAHOE STRANGLER”

In the late 1970’s, two unsolved murders stump investigators for decades.

Ep. 410 – ROBIN BROOKS – “STABBING IN SACRAMENTO”

In 1980, a young woman is murdered inside her apartment.

Ep. 411 – ANGELA BROSSO & MELANIE BERNAS – “THE PHOENIX CANAL KILLER”
When two young women are murdered ten months apart in 1992, police fear that a serial killer might be plaguing Phoenix, Arizona.

Rp. 412 – DIANE DAHN – “MOMMY HAS BEEN MURDERED”
In 1988, the murder of a young mother haunts police for 30 years until investigative genetic genealogy provides groundbreaking answers.

Ep. 413 – CATHY SWARTZ – “THE KILLER REALTOR”
In 1988, the unsolved murder of a young mother haunts police for decades until a groundbreaking new science provides long awaited answers.

Ep. 414 – SHANNON LLOYD & RENEE CUEVAS – “DOUBLE HOMICIDE IN THE OC”
When the bodies of two young women are discovered in Orange County, California, a decades-long investigation ensues to identify their killer.

In 1990, when a young woman is kidnapped and sexually assaulted, she never loses hope that her attacker will be caught.
